A £70 deposit (*non-refundable) is charged for non-funded places held for children due to start in future weeks or for children not attending due to parent's leave of absence e.g. maternity leave, 46-week teacher contracts/holiday leave.

All charges in addition to Funded Early Learning or Free Entitlement will be payable in advance monthly on the last Friday of the month before childcare commences.

A receipt will be given for any monies paid for the parent/carer only via Babysdays.

Payment for the month is in advance, paid on or before the 3rd of the month childcare will be commencing. If payment is not received within the specified time, then we will apply a late charge of £32 per day per child. We reserve the right to also withdraw childcare thereafter.

Any increase in charges will be given to parents at the beginning of the financial year April 6th to April 5th. These charges will be reviewed in the contract and applied to the following month onwards.

Some parent/carers will be entitled to additional financial support from other funding streams e.g. Childcare vouchers that maybe available through their employers or the childcare element of Working Tax Credits or Tax Free Childcare. Please see the weblink <https://www.childcrechoices.gov.uk>. If a parent is claiming the childcare element of the Working Tax Credit they **cannot** claim this for the time the child is in

receipt of the Funded Early Learning/Free Entitlement places

Extended Entitlement				
<p>A further 570 hours of extended entitlement childcare are available for eligible families. The eligibility criteria for this is available on the government website. It is the parents responsibility to check their eligibility through HMRC and they must provide an eligibility code to ourselves for checking with the Local Authority prior to being able to take up the extended offer. We only offer our '30 hours' as 1140 hours stretched over 50 weeks of the year, giving an average of 22.8 hours per week. We are able to offer places at NIL COST, as shown below, subject to availability. Please see our Admissions Policy for further information. Where you choose to attend all year round then your total funding entitlement will be accounted for on your invoice and shown as a number of hours. This sum equates to your 'free' entitlement from the government and the balance relates to the fees for your remaining childcare services.</p>
